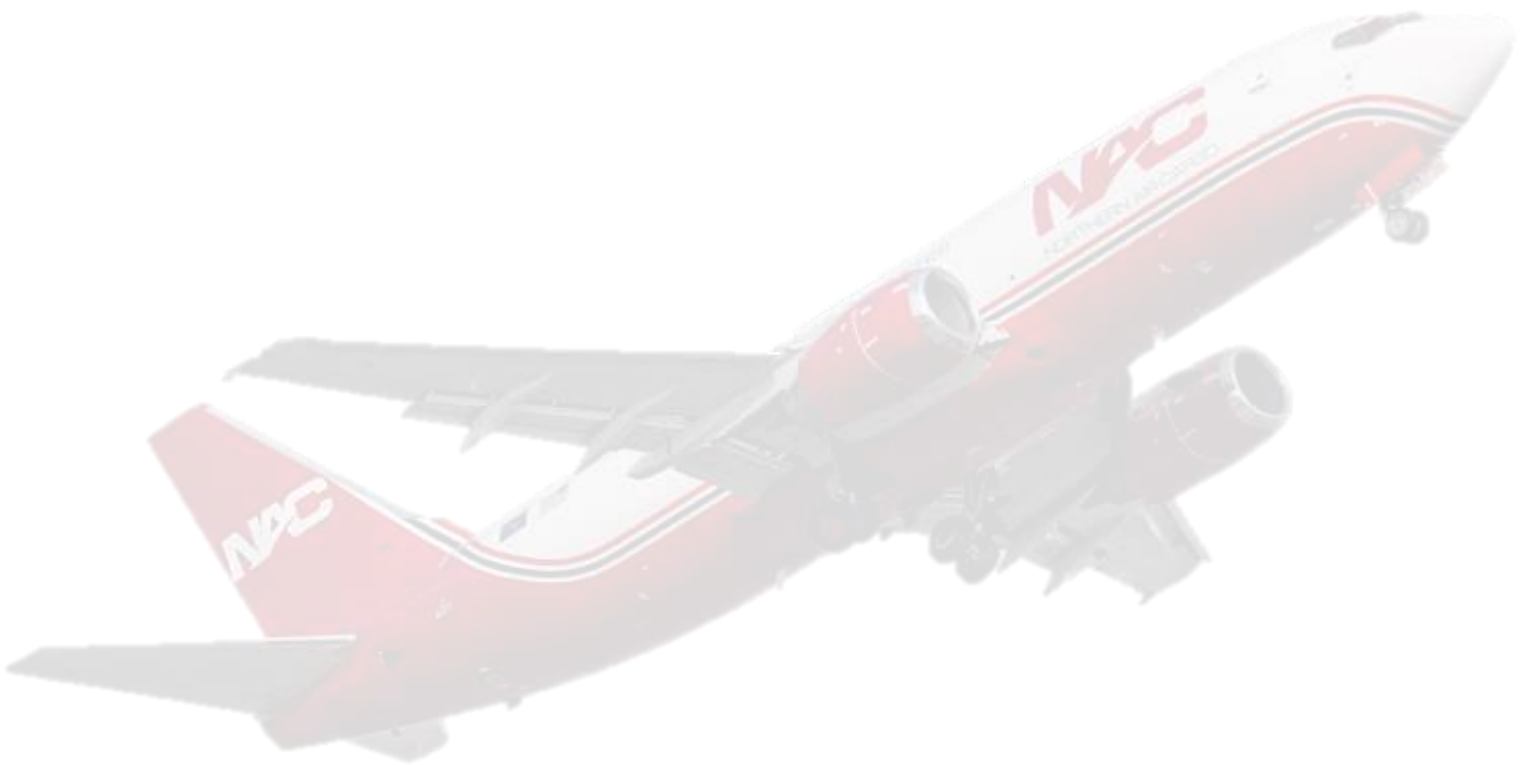

EXAMPLE

- 1 Shipper:**
Enter full name and address of the shipper
- 2 Consignee:**
Enter full name and address of the recipient
- 3 Page of pages**
The current page number and the total number of pages.
(e.g. Page 1 of 2 Pages & Page 2 of 2 Pages if more than one page)
- 4 Shipment Type:**
Delete "RADIOACTIVE" for shipments which do not contain radioactive material.
- 5 Transport Details:**
Delete "Passenger and Cargo Aircraft" *(for shipments which must travel on Cargo Aircraft Only) as shown.*

Delete "Cargo Aircraft Only" *(for shipments which may travel on either Passenger or Cargo aircraft).*
- 6 Airport of Departure: (Optional)**
Full name of the airport or city of departure.
- 6 Airport of Destination: (Optional)**
Full name of the airport or city of destination.

Delete "NON-RADIOACTIVE" for shipments which contain radioactive material.

EXAMPLE

- 7a UN or ID Number:** List the identification number assigned to the proper shipping name. These numbers are preceded by UN/ID or NA.
- 7b Proper Shipping Name:** Descriptions of materials designated as Dangerous Goods. Spelling must be as shown in the Dangerous Goods table.
- 7c Hazard Class:** List the designation of the hazard class or division corresponding to each proper shipping name.
- 7d Subsidiary Risk:** Additional label codes are indicating a subsidiary hazard.
- 7e Packing Group:** Packing groups assigned to a material corresponding to the proper shipping name and hazard class of the material.
- 7f Quantity and Type of Packaging:** Enter number of packages, package type and quantity per package. Package quantity is net unless noted as a gross quantity.
- 7g Packing Instruction:** IATA shipments, enter packing instruction shown in the dangerous goods table corresponding to the packing group. 49CFR shipments, this column should be left blank.
- 7h Authorization / ERG:** Supplemental information for the shipment to include; special permits, competent authorities and approvals.

EXAMPLE

- 8a** **Additional Handling Information:** Includes, but not limited to; Division 4.1 self-reactive substances and Division 5.2 organic peroxides. The shipper must indicate that the packages containing such substances must be protected from direct sunlight and stored away from all heat sources in a well ventilated area.
- Infectious Substances and Controlled Substances, the name and telephone number of a responsible person must be included on the Shipper's Declaration.
- 8b** **24 Hour Emergency Contact Telephone Number** – If a dangerous good is being offered, a telephone number must be provided in the event of an emergency involving the dangerous good. This number must include area code or the international access code.
- 9** **Name and Title of Signatory** – Enter legibly the name and title of the person actually signing the Shipper's Declaration. *(NOTE: title is optional)*
- 10** **Place (optional) and Date:** The place and date is entered to indicate where and when the document is actually signed.
- 11** **Sign the document** - A typewritten signature is permissible under 49CFR but must be handwritten under IATA.
