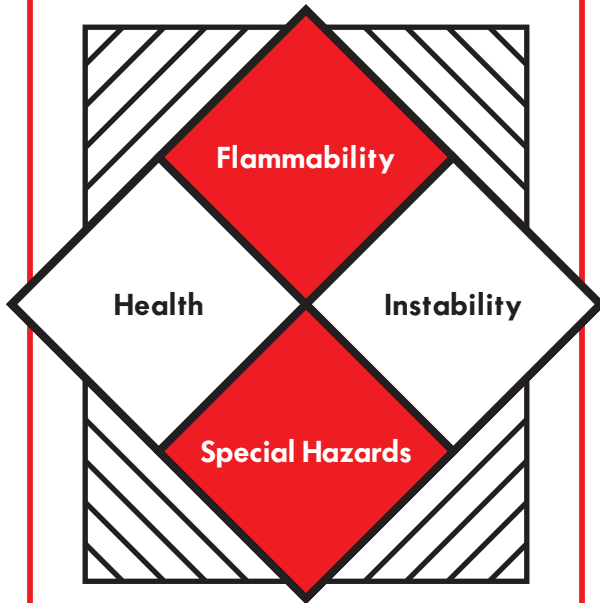


## WHAT IS A DANGEROUS GOOD

Dangerous Goods are items or substances that when transported by aircraft are a risk to health, safety, property or the environment.

## DO YOU KNOW WHAT YOU ARE SHIPPING?

There are many types of Dangerous Goods. Everything from lithium batteries to pressurized whip cream cans are considered to be Dangerous Goods when loaded into an aircraft. Altitude and pressurization can change the stability of many products.



## NOT SURE ABOUT YOUR SHIPMENT?

Common Dangerous Goods include ammunition, fuel, cleaners, batteries, paint, generators and anything with a motor. If you are unsure, ask before you ship.

## HAVE YOU DECLARED IT?

Cargo containing Dangerous Goods is subject to national and international regulation. Such cargo must be properly declared and clearly identified.

## DANGEROUS GOODS CATEGORIES OF SERVICE AND FEES

Category	Service level	Fee*
PKA	Documentation for declared Dangerous Goods	\$25.00
PKB	Proper packaging for compliance required	\$40.00
PKC	Documentation and packaging for compliance required	\$90.00
PKD	Complex documents and packaging for multiple items on an Airway Bill	\$165.00

\* Fees do not include the airline handling of \$60.00 for Dangerous Goods, cost of packaging material, or freight cost.
